



## <u>PRESS RELEASE</u> SOL Group: SOL India celebrates the laying of the foundation stone of its new ASU (Air Separation Unit) in Ranipet.

The state-of-the-art facility will be dedicated to the production of a wide range of industrial gases, including liquid oxygen, nitrogen and argon, high purity oxygen and nitrogen (especially for the Semiconductor industries), and will supply various medicinal, industrial, and scientific customers for more than 90 different applications.

SOL India's Medical Oxygen supply to Covid-19 patients during the Pandemic shows its social consciousness towards Tamil Nadu. This is also a proud moment to quote that SOL India is already contributing to ISRO's - Indian Space Research Organisation - amazing story by supplying Liquid Nitrogen and Liquid Oxygen.
