2.3. Other hazards

5.2. Special hazards arising from the substance or mixture

7.1. Precautions for safe handling

Safe handling of the gas receptacle

Safe use of the product

Only experienced and properly instructed persons should handle gases under pressure.

Ensure the complete gas system was (or is regularily) checked for leaks before use.

CO2 has been shown to enhance the production of carboxy- or met-hemoglobin by these gases possibly due to carbon dioxide's stimulatory effects on the respiratory and circulatory systems.
